ENNACOMPLEX 271 Toning Complex for the Eyelids

DEFINITION

ENNACOMPLEX 271 is a botanical complex intended to formulate eyelid and eye contour toning preparations. It softens and soothes, tones and restructures the skin, restores elasticity, and reduces pouches. It is especially recommended for toneless and stressed eyelids.

COMPOSITION

Mixed extracts of Lady's mantle, Horsetail, Ivy, and Chamomile, made with water and propylene glycol as solvents.

► COSMETIC ACTIVITY

The antiinflammatory and soothing properties of *Chamomile* (rich in azulene, flavonoids and sesquiterpenoid lactones) make it useful in reducing eyelid and eye contour discomfort.

Horsetail (rich in restructuring minerals and toning flavonoids), *Lady's mantle* (rich in vasculotonic tannins such as agrimoniin and pedunculagin), and *Ivy* (rich in softening and slightly astringent saponins) help to restore the elasticity and suppress the pouches. They exert their action by stimulating the synthesis of elastic fibres such as collagen and elastin. They also have interesting astringent and micro-circulatory effects.



A clinical study has been performed to show the efficacy of ENNACOMPLEX 271 in reducing abnormalities in eyelid tone.
